A QUICK HISTORY

1776- DECLARATION OF INDEPENDENCE 1788- THE CONSTITUION

- 15th Amendment (1870)- African-Americans
- 19th Amendment (1920)- Women
- 24th Amendment (1964)- Poll Taxes
- 26th Amendment (1971)- Voting Age 18

1965- VOTING RIGHTS ACT 2013- SHELBY V. HOLDER

- Requiring photo ID
- Requiring proof of citizenship



Nonprofits make the difference

- Reach engage communities overlooked by others and help them vote at higher rates.
- Unique assets high levels of trust, cultural competency, and ongoing interaction
- Affirmed by the IRS nonprofits are encouraged to do nonpartisan voter education under IRS guidelines







Know your stuff

- Laws vary from state to state, so visit nonprofitvote.org/voting-in-your-state/
- Ensure all staff participating in registration efforts understand rules regarding remaining nonpartisan and eligibility requirements
- Learn your deadlines, early voting periods, and how to secure absentee/mail in ballots



Best practices for success

- Get buy in from staff and leadership
- Assign a point person to coordinate efforts and ensure registration forms are turned in on time
- Integrate voter registration into existing activities (at intake, during classes or meetings, during planned events)
- Paper vs online: You can register more people at once using paper, but online has a better completion/errorfree rate. Think about what works best for you and plan around it.



Voter education and GOTV

- Educate voters on what it will be like to vote
 - Ask local election officials if you can train people on how to vote on voting machines
- Educate voters on what is on the ballot
 - Don't tell people who to vote for, but make sure they understand the races in the election
 - Supply a sample ballot (try your local League of Women Voters)
- Get out the Vote
 - Provide rides to the polls
 - Ensure people have the ID they need to vote




OPTIONS FOR INTEGRATING VOTER REGISTRATION

- Materials in lobby
- Registering during intake
- Include in case management
- Voter registration drives
- CAB sponsorship
- Find community partners

- No Time
- No ID
- No Home
- Criminal Record



CHECK LOCAL LAWS FOR REQUIREMENTS

- → Mailing Address
- →Photo Identification
- → Citizenship
- →Criminal Background



REGISTRATION DOS AND DON'TS

<u>DO</u>

- Assist with forms
- Educate about voting process
- Offer the HCH project as a mailing address
- Discuss importance of policy
- Offer to mail in forms
- Check state/county law

DON'T

- Refuse anyone the opportunity to register
- Attach information to the registration forms
- Discuss the candidates' positions on issues
- Have any materials endorsing candidates or parties

OTHER ELECTION ACTIVITIES

Leading up to the election

- ✓ Early voting
- ✓ Absentee ballots
- ✓ Locating polling places
- ✓ Sample ballots, voting machines
- ✓ Non-partisan issue education


On election day

- ✓ Transportation to the polls
- ✓ Go the polls together
- ✓ Get out the vote rally
- ✓ Volunteers at polling places

VOTER REGISTRATION AT HOUSTON HCH

- Consumer Driven
- Every Monday year-round
- Extensive work with local election board
- Get out the vote campaign
